How do I purchase a Parking Permit?

Rules and Regulations

1. By signing the transportation permission form, you are agreeing to abide by all parking rules and regulations, and acknowledging that operating and parking a vehicle on school property is a privilege conditioned on the willingness to have that vehicle subject to search by school authorities any time the vehicle is on school property.
2. A student who will operate and park a vehicle on school property must read and abide by School Policy 226 (relating to school searches), which permits randomized searches of students and their vehicles on school property.
3. Student Parking Permits may be revoked at any time by Central Dauphin High School as a means of consequence and/or failure to comply with the rules set forth on this document and/or violating the District's Drug and Alcohol Policy.
4. If your parking permit is revoked, your money will not be refunded.
5. Valid Parking Permit must be displayed on inside front windshield on the bottom right passenger side.
6. Parking Permits are **not transferable**.
7. **General Student Parking** is in the lot next to the tennis courts, behind the gym and cafeteria.
8. The **Small Parking Lot by the Music Wing** is reserved for CO-OP, HACC, and CASA students. Those students **MUST** park in this lot. Unauthorized parking will result in fine and/or possible towing at owner's expense.
9. The **Front Parking Lot** is reserved for visitors and selected staff. Students are not permitted to park there.
10. Marked **spots by the cafeteria** are reserved for cafeteria staff. Do not park in those spots.
11. Vehicles must be properly parked **between the white lines**.
12. The speed limit on school property is **15 MPH**.
13. Every student must register any vehicle they intend on driving to school. If you drive a different car that is not registered, please see **Mrs. Thomas** in the morning before school.

Consequences for Violations

Violations (driving without a permit, parking in unauthorized areas, etc.)				
1 st Violation – Warning	2 nd Violation - \$10 Fine	3 rd -5 th Violation - \$20 Fine After the 5 th violation, your permit may be revoked. Violations after the 5 th may result in the vehicle being towed.	Driving through Medians/Over Grass = \$20 Fine (No warning)	Reckless/careless driving = \$20 Fine (No warning) May result in permit confiscation.

- Fines will become obligations and will cause diplomas and prom attendance to be withheld until resolved.
- Parking Lot Attendants and Administration reserve the right to adjust consequences as needed

I also understand that it is my responsibility to obey the 15 MPH speed limit on school grounds, to operate the car safely going to and from school and all school events, to display properly the school parking sticker and to maintain legally required insurance on the vehicle. Finally, I understand that any violation of this agreement or other school rules can lead to the revocation of all parking privileges and possible disciplinary action. I further understand that motor vehicles in violation of this regulation may be subject to towing at the expense of the vehicle owner.
