Health & Safety Plan:

Ms. Sarah Box, Director of Pupil Services) presented an overview of the Health and Safety Plan.

During the timeframe of our last meeting and the February 7, 2022, School Board Meeting, the Board voted to make masking optional (recommended) and ceasing Contact Tracing effective **February 22**, **2022**.

Mitigation efforts will still be in effect regarding social distance (when feasible) and cleaning and sanitizing buildings.

COVID Trends in the schools tend to align with county data. School Case counts are dropping as is the current County number of new cases.

Most of the classroom cases can be attributed to cohorts of students participating in sports/band within the community.

The objective is/was to stay open for in-person learning. The CDSD is also navigating through staffing shortages in most areas due to COVID.

The CDSD follows CDC Guidance in terms of individuals that test positive for COVID. Guidance is a 5-day quarantine period, followed by 5 days of masking.

The CDSD offer COVID-19 Testing for Symptomatic Students and Staff through Quest Diagnostics. Quest has a 5-day turnaround time. The district is currently researching the possibility of rapid testing which has a 15-minute turnaround time. Home COVID Tests are acceptable.

The district consults with the PA Department of Health, PA Department of Education, Capital Area Intermediate and the district physicians for advice and direction.
